**MEMBERSHIP TYPES**

- Yearly Plan – 12 monthly one hour sessions @ 1 Payment of \$539**
- Quarterly Plan (1 year agreement) – 12 monthly one hour sessions** Prepaid every three months @ \$147.00
- Monthly Plan - one hour sessions @ \$55.00 paid monthly**
  
- Yearly Plan – 12 monthly 90 minute sessions @ 1 Payment of \$745**
- Quarterly Plan (1 year agreement) – 12 monthly 90 minute sessions** Prepaid every three months @ \$204.00
- Monthly Plan – 90 minute sessions @ \$76.00 paid monthly**

**TERMS AND CONDITIONS**

1. Each month of membership includes

- one 1 Hour massage per month for 1 Hour package, or one 90 minute massage per month for 90 minute package
- Every other massage during contract period is \$40 per massage for 1 Hour package, or \$55 per massage for 90 minute packages. Payment is made at time of massage.
- 1 gift certificate **per year** to give to a friend

2. Members' Dues are paid by the following method

- MONTHLY- automatic withdrawal (recurring billing), for period of one year from time of contract initiation.
- QUARTERLY- paid either in person or through PayPal every three months for a period of one year from time of contract initiation.
- YEARLY- paid either in person or through PayPal once per year.
- (Note: A \$10 fee will be applied for each credit card denial. It is up to the member to maintain account balances and current credit card information.

3. All memberships will continue as recurring unless notification is given to discontinue after completing term of membership commitment. Monthly Membership may be canceled anytime

after the first three 3 months with a 30 day written notice. Quarterly and Yearly memberships have a 1 year commitment and there will be a \$50 cancellation fee.

4. Upon expiration or cancellation, unused complimentary massages are lost and have no cash value.

5. Membership is Valid only for contracted member. However, if contracted member is not able to make the preset appointment and wishes to allow an immediate family member to use that massage, it is allowed. Contracted member must call 24 hours in advance of change.

6. Management has the right to terminate this agreement at any time with written explanation.

7. Unused massages will NOT be "Rolled-Over" to the next month.

8. Monthly massage is a minimum of 60 or 90 minute session, depending on program. It can be extended for an additional fee.

**CANCELATION OF MEMBERSHIP DURING INITIAL TERM:**

You may cancel this agreement during the initial term of your membership upon the following conditions:

- a) You change your permanent residence to a location more than 60 miles from Intuitive Touch Massage
- b) Any Permanent physical disability that would not allow you to receive massage
- c) A personal or family emergency that is brought to the attention of Intuitive Touch Massage

**LATE CHARGE:** If all or part of any scheduled payment is more than 10 days late, we may charge you a late fee of \$10.00.

**UNFORSEEN CIRCUMSTANCES:** If Intuitive Touch Massage moves more than 30 miles from their current location in Arroyo Grande, or if the business is dissolved, the contracted member will receive a refund for any massages they have left.

**REFUND POLICY:** All Sales are final. If buyer does not honor the contract, all promotional discounts must be paid in full.
